**RESOLUTION NO. 2026-14**

**A RESOLUTION OF THE CITY COUNCIL FOR  
THE CITY OF FAIRFIELD BAY, ARKANSAS,  
ACCEPTING DONATION  
FROM AN ANONYMOUS DONOR  
FOR LIGHTS ON THE PICKLEBALL COURTS;  
APPROPRIATING FUNDS; AND  
AMENDING THE 2026 BUDGET;  
AND FOR OTHER PURPOSES**

*WHEREAS*, The City Council for the City of Fairfield Bay joins the Mayor, and the Recorder-Treasurer, in accepting and receiving a donation from an anonymous donor, designated for use to install lighting at the Pickleball Courts;


*NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL FOR THE CITY OF FAIRFIELD BAY, ARKANSAS:*

1. That the City Council authorizes the Mayor of Fairfield Bay to accept a donation from an anonymous donor, up to \$3,000.00. The funds are for lawful purposes of the City, restricted to the purpose of installing lights at the Pickleball Courts.
2. The Recorder-Treasurer shall maintain a separate accounting in her records for donations made for this purpose, and accepted by the City Council, in this calendar year 2026. Donated funds shall be designated as "unavailable for appropriation" by the City for any purpose other than this use, as specified by the anonymous donor.
3. The City Council hereby, APPROPRIATES, AUTHORIZES, AND APPROVES the sum of up to \$3,000.00, from donated funds, to install lighting at the Pickleball Courts, for the calendar year ending December 31, 2026; the 2026 Budget is amended accordingly. The 2026 Budget Ordinance for the City of Fairfield Bay will be amended separately, in accordance with the City's usual practice.
4. The Mayor and the Recorder-Treasurer be, and they are hereby, AUTHORIZED TO TAKE any and all appropriate actions necessary in accordance with this Resolution, for the calendar year ending December 31, 2026.
5. This authorization is effective immediately following its approval by the City Council.


