RESOLUTION NO. 2026-16

**A RESOLUTION OF THE CITY COUNCIL FOR
THE CITY OF FAIRFIELD BAY, ARKANSAS,
ACCEPTING DONATION
FROM OZARK HEALTH FOUNDATION
FOR INTERIOR PAINTING OF THE FAIRFIELD BAY CONFERENCE CENTER;
APPROPRIATING FUNDS; AND
AMENDING THE 2026 BUDGET;
AND FOR OTHER PURPOSES**

WHEREAS, The City Council for the City of Fairfield Bay joins the Mayor, and the Recorder-Treasurer, in accepting and receiving a donation from the Ozark Health Foundation, in the amount of \$3,500.00 as designated for use to paint part of the interior of the Fairfield Bay Conference Center;


NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL FOR THE CITY OF FAIRFIELD BAY, ARKANSAS:

1. That the City Council authorizes the Mayor of Fairfield Bay to accept a donation from the Ozark Health Foundation in the amount of \$3,500.00. The funds are for lawful purposes of the City, restricted to the purpose of painting parts of the interior of the Fairfield Bay Conference Center.
2. The Recorder-Treasurer shall maintain a separate accounting in her records for donations made for this purpose, and accepted by the City Council, in this calendar year 2026. Donated funds shall be designated as "unavailable for appropriation" by the City for any purpose other than this use, as specified by the Ozark Health Foundation.
3. The City Council hereby, APPROPRIATES, AUTHORIZES, AND APPROVES the sum of \$3,500.00, from donated funds, to paint certain interior parts of the Fairfield Bay Conference Center, that is, for labor, materials, and supplies, for the calendar year ending December 31, 2026; the 2026 Budget is amended accordingly. The 2026 Budget Ordinance for the City of Fairfield Bay will be amended separately, in accordance with the City's usual practice.
4. The Mayor and the Recorder-Treasurer be, and they are hereby, AUTHORIZED TO TAKE any and all appropriate actions necessary in accordance with this Resolution, for the calendar year ending December 31, 2026.


5. This authorization is effective immediately following its approval by the City Council.
