RESOLUTION NO. 2022- 46

**A RESOLUTION OF THE CITY OF FAIRFIELD BAY,
ARKANSAS,
AUTHORIZING THE MAYOR
AND RECORDER-TREASURER
TO TRANSFER FUNDS FROM THE
FEDERAL AMERICAN
RESCUE PLAN ACT FUNDS ACCOUNT
TO THE GENERAL ACCOUNT
TO REIMBURSE THE CITY FOR
POLICE DEPARTMENT PERSONNEL EXPENSES
FOR THE THIRD QUARTER OF
CALENDAR YEAR 2022;
APPROPRIATING FUNDS ACCORDINGLY;
AND FOR OTHER PURPOSES**

WHEREAS, the City has received funds from the Federal Government pursuant to the American Rescue Plan Act, has segregated those funds in a specific account, and has received notice from the federal government that regulations concerning those funds have become final; and

WHEREAS, the City wishes to reimburse its general fund for Police Department personnel expenses (within federal guidelines, laws, and limitations) for the third quarter of the 2022 Calendar Year, from federal funds pursuant to the American Rescue Plan Act (ARPA), to the extent federal funds are available; and

WHEREAS, the City has evaluated the appropriate expenditures of funds, and the appropriate uses of federal funds, and concludes that reimbursement for certain city general revenue expenses are authorized by federal law, as set forth herein;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL FOR THE CITY OF FAIRFIELD BAY, ARKANSAS, that:

1. The Mayor, and the Recorder-Treasurer, be, and they are hereby AUTHORIZED TO TRANSFER FUNDS IN THE FEDERAL ARPA ACCOUNT TO THE CITY'S GENERAL ACCOUNT, in the amount of \$108,127.94, for the purpose of

reimbursing the City's general funds account for Police Department expenses for the third quarter of calendar year 2022.


2. The City hereby APPROPRIATES FROM THE CITY'S PORTION OF THE AMERICAN RESCUE PLAN ACT GRANT a total amount of \$108,127.94, to claim police salary and employer contribution and other appropriate Police Department expenses from July 1, 2022, to September 30, 2022. A separate amendment to the City's Budget Ordinance may be done in accordance with the City's practices of amending the Budget, as necessary.
3. This authorization, and appropriation, is effective on the first calendar day immediately following its approval by the City Council, and the transfer may take place as the Recorder-Treasurer shall decide.

IT IS SO RESOLVED on this 10th Day of October, 2022, by the City Council of the City of Fairfield Bay, Arkansas.
